1 position for Complaints Committee - Complaints board deals with any complaints raised through OUSU's statutory complaints procedure. Successful candidates will serve for one year.

Lawrence Houldsworth (Christ Church) was elected.

2 positions for the University Rules Committee - A very important University committee that reviews the rules on student behavior and discipline.

Adam Tyndall (Hertford):

1.Electoral Review Group

Council Notes:

- 1. The statutory elections in 6th Week.
- 2. That there were significant technical difficulties with the online voting system.
- 3. That various Standing Orders were identified in the rulings of the Returning Officer as needing to be changed.
- 4. That last year an Electoral Review Group was established to investigate concerns relating to low turnout.

Council Believes:

1. That a report on the Standing Orders and practices associated with the elections is desirable.

Council Resolves:

- 1. To create, with immediate effect, an Electoral Review Group to review Section C of the Standing Orders and all practices associated with the elections.
- 2. To appoint to the Electoral Review Group:
 - a. the current Returning Officer (Jonathan Edwards of Balliol College),
 - b. the current Deputy Returning Officer (Jim O'Connell of University College),
 - c. the current President (Martha Mackenzie of St John's College).
- 3. To appoint to the Electoral Review Group any persons in the following categories who express interest in being part of the Group:
 - a. the candidates for Sabbatical Office,
 - MINUTES OF 7TH WEEK COUNCIL MT11

- b. the Principal Agents of the candidates for Sabbatical Office,
- c. the Student Trustees-elect.
- d. the current Sabbatical Officers.
- 4. To mandate the Electoral Review Group to advertise for submissions from any interested member of OUSU and to consider any that are received.
- 5. To mandate the Electoral Review Group to issue a report to this Council at its meeting in 5th Week of Hilary Term 2012, suggesting such changes as it considers necessary or desirable. This report must include as an appendix a summary of all submissions received before Friday of 2nd Week of Hilary Term 2012.

Jonathan Edwards (Balliol):

Problems came up with the Statutory Election, I think it would be good if a group was formed to look into it.

2. Motion to investigate the use of and the financial commitment of OUSU to the 'Safety Bus' partnership with Oxford Brookes. (Finalised Motion with Amendments)

OUSU Council Notes:

- 1. The 'Safety Bus' is a joint partnership between OUSU and Oxford Brookes Student Union (OBSU). The service is made up of volunteers from Oxford University and Oxford Brookes and provides transportation around Oxford to those who contact the service between 9PM and 3AM, when volunteers are available to staff the service.
- 2. The current use of the safety bus by Oxford University students is undocumented.
- 3. The proposed financial commitment for the service is £12000.

OUSU Council Believes:

- 1. That the current commitment to the 'Safety Bus' partnership needs to be evaluated to justify the current financial commitment.
- 2. That any future commitments should be postponed until the evaluation of the 'Safety Bus' is completed.

OUSU Council resolves to:

- 1. Mandate the VP Women and VP Charities and Communities, who are currently charged with overseeing the service, to evaluate and consider ways to increase and improve upon current efforts to promote usage of the 'Safety Bus.'
- 2. Mandate the VP Women and VP Charities and Communities to evaluate current usage of the safety bus.
- 3. To mandate VP Women and VP Charities and Community to ensure the continuation of the service throughout the evaluation/investigation.

Alexander Lans (St. Catherine's College) Proposed by:

Alex Lans (St Catherine's):

Met in budget committee and had questions about current use of safety bus, current commitment of £12,000. We should carefully look at, certainly something used by Oxford Brookes but not clear how many Oxford students use.
